Dear Stagecoach Property Owner:

Attached are two City of Stagecoach ordinances that are applicable to any grading, timbering or building construction or reconstruction on any properties within Stagecoach's City limits. Included are the City's:

- ▶ PLANNING & ZONING ORDINANCE # O-2015-68 - Effective April 1, 2015;
- ▶ FLOODPLAIN ORDINANCE # O-2014-258 - Effective August 18, 2014.

The owner and builder must complete an Application for Building Permit and a Declaration of Compliance with regard to cutting trees. For new construction, a floodplain certificate is required in order to obtain a septic permit from Montgomery County. The City's Floodplain Administer will issue a Certificate of Lot in Relation to Floodplain as required for each lot. If the property is located in the 100-year floodplain, a Floodplain Development Permit will also need to be obtained. There is a checklist of compliance requirements for projects requiring architectural plans.

Each of these ordinances is fairly self-explanatory. However, if you still have questions after carefully reading each ordinance please call the undersigned for assistance. Applications for permits are to be delivered or mailed to the undersigned at the City Center. Incomplete applications will be returned to the applicant noting the deficiencies in the application packet.

The Planning and Zoning Commission meets the second Tuesday of every month at 7:00 p.m. at the City Center to review applications. The application must be turned in to the City Secretary at least five (5) days prior to the meeting in order for it to be reviewed at the meeting.

The City of Stagecoach office hours are 8:30 a.m. to 12:00 p.m. and 1:00 p.m. to 5:00 p.m., Monday through Thursday.
