

Motion was made by Donald Pratorius, seconded by Robert Hanson, that the following Ordinance be passed:

NO. 108107

AN ORDINANCE BY THE TOWN OF STAGECOACH, TEXAS,  
RESTRICTING PARKING OF VEHICLES ON SHADY OAKS DRIVE  
DURING CERTAIN PERIODS; PROVIDING FOR MARKING AREA;  
REPEALING ALL ORDINANCES IN CONFLICT; PROVIDING  
PENALTY, AND EFFECTIVE DATE.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF  
STAGECOACH, TEXAS:

I.

That it shall be unlawful for any owner or operator  
of a vehicle to park same on Shady Oaks Drive, at the locations  
hereinafter set out:

- (1) BEGINNING at the intersection of Shady Oaks  
Drive and Stagecoach Road;  
THENCE North along both sides of Shady Oaks  
Drive a distance of 850 feet.
- (2) BEGINNING at the intersection of Shady Oaks  
Drive and Stagecoach Road;  
THENCE in a Northwest direction along both  
sides of Stagecoach Road a distance of 1200  
feet to a point just North of the intersection  
of Old Coach Road and Stagecoach Road.

from 11:00 o'clock P. M. to 6:00 o'clock A. M. of each and  
every day.

II.

That the above restricted parking areas shall be  
properly marked to identify "No Parking from 11:00 o'clock  
P. M. to 6:00 o'clock A. M."

III.

That all Ordinances or parts of Ordinances in con-  
flict herewith are hereby repealed.


IV.

That any person, firm or corporation violating any  
of the provisions of this Ordinance, shall be fined in a sum  
not more than Two Hundred and No/100 (\$200.00) Dollars for  
each offense, and a separate offense shall be deemed committed  
on each day during or on which a violation occurs or continues.


VI.

That this Ordinance shall take effect and be in force from and after its passage.


